

Kashi also known as Benares or Varanasi, is a holy city on the banks of River Ganges. A major religious hub in India, it is the holiest of the seven sacred cities (SaptaPuri) according to Hinduism .It has been an ultimate pilgrimage dream destination for Hindus since ages. "Mark Twain said" Benares is older than history, older than tradition, older even than legend and looks twice as old as all of them put together "It is believed that the gods graced the earth from this holy land .The Ganges in Kashi is believed to have power to wash away the sins of mortals. Kashi is also witness to key Hindu events of astounding range and depth due to the important people who came to its Ghats, the steps that lead down to the Ganga, 'the river of salvation'. One among them is the revered Vedic sage Maharishi Kashyap. Considered as one of the Saptarishis in Rig-Veda. Maharishi Kashyap dwelt in "Kashyappuri" or "Kachhwa" as it is known today, is famously acclaimed for the 'Kund of Maharishi Kashyap'.

Kachhwa also known as Maharishi Kashyap's Ashram, It is also Known as the birth place of lord Baman (Vishnu) because Lord Baman is the son of Maharishi Kashyap and Aditi.

Late Pandit Ramkinkar ji Upadhyaywho was called as "YugTulsi" was from this holy land too. He was a very well-known Ram Katha Speaker and writer. Kachhwa is also prominently known for the holy temple of Moochwale Hanuman Ji whose 8 feet tall stone sculptured idol is unique in the world, this mudra or pose is found nowhere else.

Late Pandit Chandrasekhar Mishra Vyas ji "Ramayani", who organised RamcharitramanasSammelan& Hanuman Jayanti annually to mark his birth in Kartik Maas. Also was a Siddhapurush, spiritual master for many, a kathasagar of yesteryears, a great astrologer guiding the troubled, from the religious land of the Moochwale Hanuman Temple, the only Temple of the Jagruth Moustached Hanuman in the world. He was a wellknown preacher for Ramcharitramanas (literally, The Ramayana composed by Tulsidas) and also was India's renowned astrologer (face-reader).this was continued by his son Shri Pandit Jageshwar Mishra ji and the legacy is now in third generation by MugdhaRicha Mishra ji.

Born to Vyas Ji, Pandit Jageshwar Mishra ji (Munajji) was born in the Kachhwa village in a pious family. From a very young age the influence of family tradition and culture had an effect on his life due to which he has been closely associated with music and Ramcharitramanas. In the field of music he was awarded National award twice in Jaipur. Well Known Singers and composers like Naushad, Khayyam, Ravindra Jain and BhupendraMitali have praised his singing from time to time.

On the footsteps of her grandfather Late Shri Chandrasekhar Mishra Ji, his granddaughter Mugdha Richa Mishra ji is also engaged with her father Pandit Jageshwar Mishra ji in pursuing a tradition of performing musical recitals of Ramcharitramanas.

Fondly addressed as Devi ji. Is a Sanskrit scholar from Kashi Sanskrit Vidyapeeth.At the age of 11 she was drawn towards the path of spirituality. She believes in "Vasudhaiva Kutumbakam" which means mankind is one religion and all religions need to be respected. She also believes that tolerance is the most important teaching in all religions across the world.

After seeing and experiencing the inequalities of the society, her deep concerns stems from the fact that all need to be happy and uplift the less fortunate of the society using the tools of spirituality from our ancient scriptures. This deep rooted concern for the less fortunate began at a young age whereby she began contributing to the society in whichever small manner she could and this continuous movement for giving back to society gave resulted in formation of this trust.

Devi ji was born and grew up in an environment where Shri Ram Katha, Shri Hanuman Katha, Shrimad Bhagwat Katha and many more pravachans were aligned to every breath of life. She has developed proficiency and command over Katha's & Pravachan's which is very evident and also can successfully touch the Mind, Heart, & Souls of all those who listen and is efficient in making a difference in their lives. For her the universe is her family and deeply associates with all that is around her, only to exalt everyone around her into a happier and fulfilling life.

She is for many a spiritual source and guiding light, like the very rays of the rising Sun touching the earth to "Awaken" every being with its gentle rays.

Our Devi ji, does all her Seva to the society, in her contributions, she believes that richness is evaluated with virtues and not with money.


is an NGO registered at Kashi (Varanasi) UP. Established in 2015 by boundless enthusiasm and tireless efforts of its Founders:-
